By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) CCM LLC, Cantillon Inc., Cantillon Management and Mr. von Mueffling may be deemed to beneficially own 4,242,919 Shares (constituting approximately 5.50% of the Shares outstanding) and (ii) Mr. von Mueffling may be deemed to beneficially own 430,000 Shares (constituting approximately 0.55% of the Shares outstanding).
